2. Minutes of Meeting held on 14 July 2015

The minutes from the CSR meeting held on 14 July 2015 were confirmed as an accurate record of the proceedings.

3. Guest Speakers

Mr Terry Simpson, Consultant

Review of Departmental Community Sector Service Expenditure

The Chair welcomed Mr Simpson to the meeting.

Ms White explained the current internal organisational review and reform processes the Department is currently undergoing. The reform processes include OOHC, improving outcomes for Aboriginal children and families and the way the Department partners with the community sector.

Mr Simpson is reviewing the community service investment priorities and principles for the Department. Primarily, seeking visibility in investments in terms of what, why and how they are aligned with best practice, including service effectiveness, efficiency, contemporary service design and delivery. Importantly, how partnerships and the services procured connect with the Department's outcomes will also be considered. The sector will be consulted.

It was noted that individual services are not being reviewed but how the Department purchases the services, what is purchased compared to what services are needed and how a more flexible use of funding maybe established to achieve outcomes.

It is anticipated that this work will be completed by the end of October. The output from this would then go to the sector for consultation. Currently seeking input from CSR members to inform this process. It was agreed to report to CSR in September and October to update on progress. Mr Carter, Ms Wallam, Ms Ash and Ms Hunt agreed to provide input out of session.

This process is separate to the Regional Reform process.

Discussion ensued on the need for clarity of funding sources and processes and the specific costing models. It was noted that one agency may deliver a program much more cheaply than others, but not provide the same range and/or quantity of support, and therefore level of service, required.

Scoping the regulatory environment was also discussed, specifically relating to the shift from a contracting and funding environment to one of procurement.

The Chair thanked Mr Simpson for his time and the work he is undertaking. Members welcomed the opportunity to engage in this process.

4. Actions Arising

4.1 Leadership and Partnership Forum and Learnings from place-based initiatives

The Chair provided the draft agenda. Mr Reid advised that Mr Grahame Searle is confirmed to present on Regional Reform, to broaden the knowledge base of participants. The Minister for Child Protection is confirmed. Mr Tom Leeming has been invited. The workshop session will incorporate Indigenous and non-government representatives where possible. Mr Searle's team is working with the CSR working group to finalise the agenda. Cabinet will endorse the Regional Reform team in the near future, including non-government and Aboriginal representatives. It is anticipated that some of these representatives will be included on the panel and participate in the workshop.

The afternoon session will focus on learnings from place based initiatives. Members agreed to invite a representative from the following to present :

Ms Benham discussed the paper provided to members prior to the meeting 'Repositioning of the OOHC System'.

This report outlines a proposal to describe the out-of-home care system under two phases:

- 1. transitional care; and
- 2. home for life care.

It is aligned and linked in the context of other reform changes, including over-representation of Aboriginal children in the out-of-home care system; realignment of district workforce; consistent carer assessment, training and approval; clarified policy on respite care; and realignment of Fostering and Adoptions Services.
